LICENSEE BARRINGS - WELFARE

LICENSEE BARRINGS - OTHER

POLICE BARRINGS - CRIMINAL INTELLIGENCE

I have been advised by South Australia Police that no barring orders were issued on the grounds of 'criminal intelligence' during the period 1 July 2013 to 30 June 2014.

REVIEW OF ORDERS CONDUCTED UNDER SECTION 128

There were 31 reviews of barring orders conducted in 2013-2014 under section 128 of the Act, compared with 56 in 2011-12.

The Act requires a report on the number of barring orders reviewed regardless of the length of time for which the barring was issued.
